CONFIRMATORY TRADEMARK ASSIGNMENT

THIS AGREEMENT is entered into nunc pro tunc, effective as of February 14, 2002, between GOSS GRAPHIC SYSTEMS, INC., a Delaware state corporation with a principal place of business at 700 Oakmont Lane, Westmont, Illinois, 60559 (hereinafter "Assignor") and GOSS INTERNATIONAL CORPORATION, a Delaware state corporation with a principal place of business at 700 Oakmont Lane, Westmont, Illinois, 60559 (hereinafter "Assignee").

WHEREAS, as of the effective date of this agreement the Assignor owns all rights, interest and goodwill in the trademarks listed in the attached Schedules A and B in the United States and in the countries indicated, and in the trademark applications and registrations therein listed in the Schedules (collectively referred to as the "Trademarks"); and

Assignor does hereby confirm that it has assigned and does hereby assign unto Assignee all of its right, title and interest in and to the Trademarks, together with the goodwill of the business symbolized thereby, the right to sue for past infringement, the right to prosecute applications and maintain the U.S. Trademark Applications and Registrations therefore identified in the attached Schedule A, and the foreign Trademark Applications and Registrations

therefore identified in the attached Schedule B.

2. Assignor shall cooperate with Assignee, at Assignee's request, to execute any and all documents and deeds that are reasonably necessary for giving full effect to the assignment contained herein.

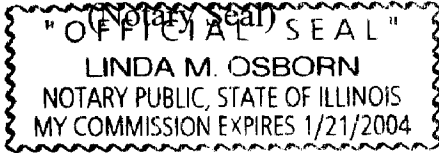

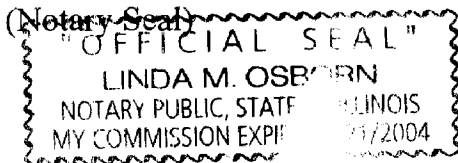
