## AGREEMENT

### PARTIES

This agreement is made as of this 18<sup>th</sup> day of December, 2002, between The Copperstone Group Ltd., an Arizona corporation ("Copperstone"), whose business address is 7401 E. ### RECITALS

- B. Western Town has objected to Copperstone's prior use of and applications to register Rawhide for various goods.

### AGREEMENT

limitation Serial Nos. 76/127166 for The Whiskey That Tamed The West Rawhide Brand and design; and 76/131493 for The Salsa that Tamed the West Rawhide Brand and design).


