## TRADEMARK ASSIGNMENT

TRADEMARK ASSIGNMENT, dated as of December 31, 2002, made by Time Warner Entertainment Company, L.P., a Delaware limited partnership ("TWE") and Time Warner Entertainment – Advance/Newhouse Partnership, a New York general partnership (together with TWE, "Assignor"), in favor of TWEAN Subsidiary, LLC, a Delaware limited liability company ("Assignee"). 


