Trademark Assignment Agreement

This Trademark Assignment Agreement (the "Agreement") is made as of June 11, 2003 (the "Effective Date") by and between PC Mall, Inc. ("Assignor"), a Delaware corporation with its principal place of business at 2555 W. 190 Street, Torrance, CA 90504, and PC Mall Sales, Inc. ("Assignee"), a California corporation with its principal place of business at 2555 W. 190th Street, Torrance, CA 90504 (referred to collectively as the "Parties" and individually as a "Party").

WHEREAS, Assignor is the sole owner of all rights, title and interest in and to the trademark CLUBMAC, United States Registration No. 1,739,578, for goods in International Class 9 identified as "computer peripherals; namely, computer hard drives, and computer software for use in word processing, data base management, records management, inventory control, and accounting" (the "Mark"), and to the goodwill and reputation of the business connected with and symbolized by this trademark;

WHEREAS, Assignor wishes to assign all right, title and interest in and to the Mark to Assignee, and Assignee wishes to accept such assignment;

NOW, THEREFORE, in consideration of the mutual agreements, provisions and covenants contained herein. the Parties agree as follows:

- Assignment. Assignor hereby transfers, conveys and assigns to Assignee all right, title and interest throughout the world in and to the Mark, together with all goodwill associated therewith, effective upon Assignor's receipt of all payments due hereunder. Assignor shall execute such written instruments and extend such other cooperation as may be reasonably necessary to convey the Mark to Assignee.
- Payment. As full payment for the assignment of the Mark, Assignee shall pay to Assignor the sum of one United States dollars (US\$1.00) on the Effective Date.
- Miscellaneous. This Agreement is made under and shall be construed in accordance with the laws of the State of California, without giving effect to any choice of law rule that would cause the application of the laws of any jurisdiction other than the internal laws of the State of California to the rights and duties of the Parties. This Agreement may be executed in two (2) or more copies, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument. If any provision or provisions of this Agreement are held to be invalid, illegal or unenforceable, in whole or in part, under any law or regulation, by a court of competent jurisdiction, then such provision or portion of such provision, as appropriate, shall remain in effect only to the extent that it is valid, and the validity, legality and enforceability of the remaining provisions of this Agreement shall remain in full force and effect and shall in no way be affected, impaired or invalidated thereby. This Agreement constitutes the entire agreement between the Parties relating to the subject matter hereof and supersedes all prior agreements, understandings and representations concerning such subject matter. No amendment or modification to any of the terms hereof shall be valid or binding upon the Parties unless made in writing and signed by duly anthorized representatives of the Parties.
