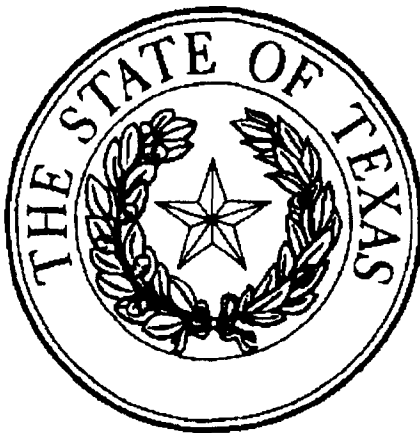

The undersigned, an officer of SOUTHWEST TEST, INC. (the "Converting Entity"), hereby

certify as follows:

1. The Converting Entity is a corporation organized under the laws of the State of Texas.
2. The Converting Entity has 250 shares of common stock issued. The holders of 250 shares of common stock of the Converting Entity have voted in favor of adoption of a Plan of Conversion.
3. Under the terms of the Plan of Conversion approved by the shareholders, the Converting Entity will, upon the issuance of a Certificate of Conversion by the Secretary of State of Texas, convert its organizational form of a Texas general partnership that shall register as limited liability partnership organized under the laws of the State of Texas to be known as SOUTHWEST TEST, LLP (the "Converted Entity").
4. An executed copy of the Plan of Conversion is on file at the principal place of business of the Converting Entity located at 1001 S. Sherman Street, Richardson, Texas 75081-4848, and will be on file in the principal place of business of Converted Entity at the same address from and after the date of conversion.
5. That copy of the Plan of Conversion will be furnished, by the Converting Entity (prior to the conversion) or the Converted Entity (after the conversion), on written request and without cost, to any member of the Converting Entity or partner of the Converted Entity.
6. The Plan of Conversion was duly authorized by all actions required by the laws under which the Converting Entity was incorporated, formed or organized and by its constituent documents.
7. The Articles of Conversion shall be effective on the date on which the Articles of Conversion are filed with the Secretary of State of Texas.
8. The Converted Entity assumes the Converting Entity's obligations for Texas franchise taxes for the period prior to effective date of the conversion.
