

In consideration of the payment in full and satisfaction of all obligations under the Credit Agreement and DIP Agreement secured by Trademarks, Secured Party, on behalf of itself and the financial institutions party to the Credit Agreement and the DIP Agreement hereby fully releases any and all interest in the Trademarks, including, but not limited to, any and all security interests recorded against the Trademarks.

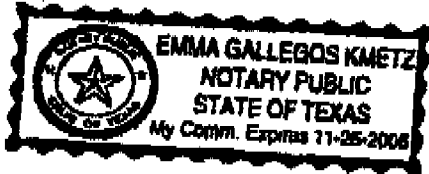
