TRADEMARK ASSIGNMENT

WHEREAS, Assignor is the owner of the United States trademark identified on the attached Schedule A (the "Assigned Trademarks");

WHEREAS, Assignor, General Mills, Inc. and International Multifoods Corporation, a Delaware corporation having a principal place of business at 110 Cheshire Lane, Suite 300, Minnetonka, Minnesota 55305 (hereinafter referenced as "Assignee") have executed an Amended and Restated Asset Purchase and Sale Agreement dated October 24, 2001 (as it may be amended from time to time, the "Asset Purchase Agreement") wherein, among other things, Assignee purchased certain retail product lines from Assignor; and
