RELEASE

(Trademarks)

This RELEASE (Trademarks) is given this 23<sup>rd</sup> day of May, 2002 by Canadian Imperial Bank of Commerce ("Assignor") to AFC Enterprises, Inc. (formerly known as America's Favorite Chicken Company, Inc. ("AFCC")), a Minnesota corporation ("Assignee"), as follows:

WHEREAS, Assignee and Assignor entered into a Trademark Collateral Security Agreement dated May 21, 1997 ("Security Agreement") pursuant to which Assignee assigned unto Assignor and granted to Assignor a security interest in all of Assignee's right, title and interest in certain collateral, including certain trademarks listed on Schedule A hereto (the "Trademarks");

WHEREAS, AFCC and Assignor entered into a Trademark Security Agreement dated November 5, 1992 ("AFCC Security Agreement") pursuant to which AFCC granted to Assignor a security interest in all of its right, title and interest in certain collateral, including certain Trademarks, and AFCC and Assignor entered into a Supplement to Security Agreement for Supplemental Patent and Trademark Office Filings dated June 25, 1993 ("Supplement") in order to perfect Assignor's security interest in certain Trademarks acquired by AFCC since the execution and delivery of the AFCC Security Agreement;

WHEREAS, AI Copeland Enterprises, Inc., a Texas corporation ("AI Copeland") and Assignor entered into a Trademark Security Agreement dated September 21, 1989 ("AI Copeland Security Agreement") pursuant to which AI Copeland granted to Assignor a security interest in all of AI Copeland's right, title and interest in certain collateral, including certain Trademarks;

WHEREAS, Biscuit Investments, Inc., a Louisiana corporation ("Biscuit") and Assignor entered into a Trademark Security Agreement dated March 21, 1989 ("Biscuit Security Agreement") pursuant to which Biscuit granted to Assignor a security interest in all of Biscuit's right, title and interest in certain collateral, including certain Trademarks;

WHEREAS, Biscuit merged with and into AI Copeland, which merged with and into America's Favorite Chicken Company which is now known as Assignee pursuant to a name change;

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office on May 30, 1997, at Reel 1590, Frame 0224;

WHEREAS, the AFCC Security Agreement was recorded with the United States Patent and Trademark Office on November 10, 1992, at Reel 0906, Frame 0926, and the Supplement was recorded with the United States Patent and Trademark Office on July 28, 1993, at Reel 1034, Frame 0273;

WHEREAS, the Al Copeland Security Agreement recorded with the United States Patent and Trademark Office on October 13, 1989, at Reel 0675, Frame 0285;

WHEREAS, the Biscuit Security Agreement recorded with the United States Patent and Trademark Office on March 30, 1989, at Reel 0644, Frame 0985; and

WHEREAS, Assignee has fully paid, performed, discharged and observed all its obligations to Assignor under the Security Agreement, the AFCC Security Agreement, the Al Copeland Security Agreement and the Biscuit Security Agreement as necessary for Assignor to grant this Release (Trademarks).

NOW, THEREFORE, Assignor hereby releases all security interest, liens, encumbrances and any other right, title and interest in or to the collateral including, but not limited to, the Trademarks, and reassigns all its right, title, and interest in such Trademarks to Assignee.
