ASSIGNMENT OF TRADEMARKS

WHEREAS, FORBES MANAGEMENT CO. NOW, THEREFORE, in consideration of and exchange for the sum of Ten Dollars (\$10.00 USD) and other good and valuable consideration, the receipt of which is hereby acknowledged, the parties agree as follows:

1. Assignor does hereby irrevocably sell, assign, transfer and deliver to Assignee, its successors and assigns, its entire right, title and interest in and to the Marks, including any applications to register, registrations and any renewals thereof, and all goodwill symbolized by and associated with the portion of Assignor's business conducted under said Marks, whether such use is or has been pursuant to license, sublicense, agreement or permission, all income, royalties, judgments and payments now or hereafter due to Assignor or payable in respect to said Marks, and in and to all causes of action, either in law or equity, for past, present or future infringement based on the Marks which have been or could be asserted by Assignor.

2. This Agreement, together with all Schedules attached hereto, constitutes the entire understanding of the parties with respect to the subject matter hereof and supersedes all prior agreements, proposals or representations, written or oral, between the parties relating to the subject matter of this Agreement.
