
RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, pursuant to the terms of that certain Security Agreement (Inventory, Receivables, Equipment and General Intangibles), dated as of January 9, 1998 (the "Security Agreement"), between Highland Group Corporation, an Ohio corporation ("Highland"), and National City Bank ("NCB"), Highland pledged and granted to NCB a security interest in the property described therein, which property includes general intangibles, including, without limitation, (a) all trademarks, trademark applications, trade styles, and trade names including, without limitation, those listed in Exhibit A attached hereto, and herein incorporated by reference, and any schedule to the Security Agreement; (b) all renewals thereof; (c) all rights to bring actions or assert claims for and collect damages relating to past infringement or improper use or disclosure of such items; and (d) all goodwill associated with any of the foregoing ("Trademarks").

NOW, THEREFORE, for good and valuable consideration, NCB does, for recording purposes, hereby release and discharge the security interest, liens and all other rights it may have in the Trademarks identified in Exhibit A attached hereto, granted to it by Highland pursuant to the Security Agreement (Inventory, Receivables, Equipment and General Intangibles), dated as of January 9, 1998, and which was recorded in the United States Patent and Trademark Office, to which reference may be had, the debt secured thereby having been paid and satisfied in full.
