### **TRADEMARK ASSIGNMENT**

This Trademark Assignment (this "*Agreement*") is made this 25th day of February, 2003, by and among, SLEEPMASTER LLC, a New Jersey limited liability company, ("*Assignor*"), and National Bedding Company L.L.C. ("*Assignee*"). All capitalized terms used herein shall have the same meanings ascribed to them in the Contribution and Acquisition Agreement dated November 22, 2002, by and among the Assignee, The Official Committee of Unsecured Creditors, Sleepmaster Holdings, L.L.C. (the "*Company*"), Sleepmaster L.L.C. and its Subsidiaries as set forth on Appendix I therein (the "*Contribution & Acquisition Agreement*").

**WHEREAS**, pursuant to the Contribution & Acquisition Agreement, the Assignor has agreed to sell, and the Assignee has agreed to purchase, all ownership, license or other right, title and interest in and to, including the right to recover any and all past and future damages from infringement, all United States, state, and foreign trademarks, trade dress, logos, trade names, service marks, service names, together with all translations, adaptations, derivations, and combinations thereof, and registrations, applications for registration, and renewals thereof and foreign counterparts thereof listed on the annexed Schedule A and any not listed therein, and related licenses and other agreements used or held for use in connection with the Assignor's business (collectively, the "*Marks*"), together with all of the associated and goodwill of the Assignor's business symbolized by said Marks.

**NOW, THEREFORE BE IT RESOLVED**, that in consideration of the payment of Ten Dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignor does hereby assign as of the first date written above to the Assignee all right, title and interest in, to and under said Marks and the registrations therefor, together with the goodwill of the business connected with the use of and symbolized by the Marks; and together with the entire business or portion thereof to which the Marks pertain; and together with all causes of action for the infringement of such Marks.

Notwithstanding anything to the contrary herein, Assignor is executing and delivering this Agreement in accordance with and subject to all of the terms and provisions of the Contribution and Acquisition Agreement (including, without limitation, Section 3.2, 6.28 and 11.3 thereof). In the event of any inconsistencies between the terms of this Agreement and those of the Contribution and Acquisition Agreement, the terms of the Contribution and Acquisition Agreement shall be controlling.

ASSIGNEE AND ASSIGNOR AGREE THAT THE BANKRUPTCY COURT SHALL HAVE EXCLUSIVE JURISDICTION OVER ALL DISPUTES AND OTHER MATTERS RELATING TO (i) THE INTERPRETATION AND ENFORCEMENT OF THIS AGREEMENT OR ANY ANCILLARY DOCUMENT EXECUTED PURSUANT HERETO; AND/OR (ii) THE MARKS, AND ASSIGNOR AND ASSIGNEE EXPRESSLY CONSENT TO AND AGREE NOT TO CONTEST SUCH EXCLUSIVE JURISDICTION

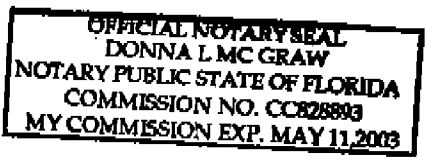
