**FIRST:** That the name and state of incorporation of each of the constituent corporations of the merger is as follows:

**EIGHTH:** The merger shall be effective at 12:01 a.m., on June 7, 2000.

NINTH: The Surviving Corporation may be served with process in the State of Delaware in any proceeding for enforcement of any obligation of Delaware, as well as for enforcement of any obligation of the Surviving Corporation arising from the merger, including any suit or other proceeding to enforce the right of any stockholder as determined in appraisal proceedings pursuant to the provisions of Section 262 of the General Corporation Law of the State of Delaware, and it does hereby irrevocably appoint the Secretary of State of the State of Delaware as its agent to accept service of process in any such suit or other proceeding.
