# CERTIFICATE OF OWNERSHIP AND MERGER MERGING WABCO MERGER SUBSIDIARY, INC. INTO WESTINGHOUSE AIR BRAKE COMPANY

Westinghouse Air Brake Company ("WABCO"), a corporation organized and existing under the laws of Delaware, does hereby certify:

FIRST: That WABCO was incorporated on the 19th day of October, 1989, pursuant to the General Corporation Law of the State of Delaware.

SECOND: That WABCO owns all of the outstanding shares of the stock of WABCO Merger Subsidiary, Inc., a corporation incorporated on the 23<sup>nd</sup> day of December, 1999, pursuant to the General Corporation Law of the State of Delaware.
