RELEASE OF SECURITY INTEREST

THIS RELEASE OF SECURITY INTEREST (the "Release") is made as of this 7th day of February, 2003, by Ableco Finance LLC, a Delaware limited liability company, as administrative agent for certain lenders ("Ableco") pursuant to that certain Financing Agreement dated as of August 30, 2002, as amended from time to time (the "Financing Agreement") in favor of Anchor Glass Container Corporation, a Delaware corporation ("Anchor").

WHEREAS, pursuant to the Financing Agreement, Anchor made that certain Assignment for Security (Patents), that certain Assignment for Security (Trademarks), and that certain Assignment for Security (Copyrights), each dated August 30, 2002 (collectively, the "Security Agreements") in favor of Ableco;

WHEREAS, the Assignment for Security (Patents) and Assignment for Security (Trademarks) were recorded at the United States Patent and Trademark Office on September 12, 2002, and the Assignment for Security (Copyrights) was recorded at the United States Copyright Office; and

WHEREAS, pursuant to the Security Agreements, Anchor granted to Ableco a continuing security interest in its right, title and interest in and to the patents and patent applications, the trademark registrations and applications, and the copyright registrations, listed on Exhibit A attached hereto and made a part hereof (the "Secured Collateral").

NOW THEREFORE, FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which is hereby acknowledged, Ableco, in its capacity as administrative agent for the Lenders (as defined in the Financing Agreement), hereby unconditionally and expressly releases and terminates its security interest in and to the Secured Collateral, and Ableco hereby assigns any such right, title and interest it may have in the Secured Collateral (if any) to Anchor.

Ableco further agrees to execute and deliver to Anchor any and all further documents or instruments and do any and all further acts which Anchor reasonably requests in order to confirm this Release. This Release shall be binding upon Ableco's legal representatives, assigns and successors.




