Trademark Assignment Agreement

This Agreement dated as of September 1, 2003, is by and between SGG TRADEMARKS LLC, a Delaware limited liability company, having a principal place of business located at 3330 Cumberland Boulevard, Suite 800, Atlanta, Georgia, 30339 ("Assignor") and RUSSELL ASSET MANAGEMENT, INC., a Delaware corporation, having a principal place of business located at 300 Delaware Avenue, Suite 1271, Wilmington, Delaware 19801 ("Assignee").

WHEREAS, Assignor is the owner of the trademarks referenced in Exhibit A attached hereto, however rendered, including all rights, title, interest and goodwill therein (the "Trademarks"); and

WHEREAS, Assignee wishes to acquire all rights, title, and interest in the Trademarks, along with all goodwill therein and Assignor wishes to assign all such rights, title and interest to Assignee.

NOW, THEREFORE, the parties agree as follows:

1. **Assignment:** Assignor does hereby irrevocably assign to Assignee all rights, title, and interest (including but not limited to, all registration and application rights with respect to the Trademarks, all rights to prepare derivative marks, and all other rights) in and to the Trademarks, along with all goodwill of the business in connection with which the Trademarks are used. Assignor further irrevocably assigns to Assignee all rights, title, and interest that Assignor may have in any particular stylization or rendering of the Trademarks, including all rights of copyright in and to the designs developed for use with the Trademarks. For purposes of Section 10 of the Lanham Act, 15 U.S.C. 1060, Assignee is the successor of the portion of the business of Assignor to which any intent to use applications listed on Schedule A pertain.

2. **Representations and Warranties:** Assignor represents and warrants to Assignee:

- (a) Assignor has the right, power and authority to enter into this Agreement;
- (b) Assignor is the exclusive owner of all rights, title and interest, including all intellectual property rights, in the Trademarks;
- (c) The Trademarks are free of any liens, security interests, encumbrances or licenses;
- (d) The Trademarks do not infringe the rights of any person or entity;
- (e) There are no claims, pending or threatened, with respect to Assignor's rights in the Trademarks;
- (f) This Agreement is valid, binding and enforceable in accordance with its terms; and
- (g) Assignor is not subject to any agreement, judgment or order inconsistent with the terms of this Agreement.

3. **Attorney's Fees:** Should either party hereto, or any heir, personal representative, successor or assign of either party hereto, resort to litigation to enforce this Agreement, the party prevailing in such litigation shall be entitled, in addition to such other relief as may be granted, to recover its or their reasonable attorneys' fees and costs in such litigation from the party against whom enforcement was sought.

4. **Entire Agreement:** This Agreement contains the entire understanding and agreement between the parties hereto with respect to its subject matter and supersedes any prior or contemporaneous written or oral agreements, representations or warranties between them respecting the subject matter hereof.

5. **Amendment:** This Agreement may be amended only by a writing signed by both parties.


6. **Severability:** If any term, provision, covenant or condition of this Agreement, or the application thereof to any person, place or circumstance, shall be held by a court of competent jurisdiction to be invalid, unenforceable or void, the remainder of this Agreement and such term, provision, covenant or condition as applied to other persons, places and circumstances shall remain in full force and effect.

7. **Agreement to Perform Necessary Acts:** Both parties agree to perform any further acts and execute and deliver any documents that may be reasonably necessary to carry out the provisions of this Agreement; to confirm, effect, enable, or evidence the assignment herein and the full enjoyment by Assignee of the rights, title, and interest transferred herein; and to effect recordal of the assignment to and ownership by Assignee of the Trademarks. Assignor agrees that it shall not adopt any mark, logo, device, or image that is similar to, calls to mind, infringes, or may dilute the Trademark or any intellectual property rights therein.

8. **Governing Law:** This Agreement shall be construed in accordance with, and all actions arising hereunder shall be governed by, the laws of the State of Delaware.


