RECITALS:



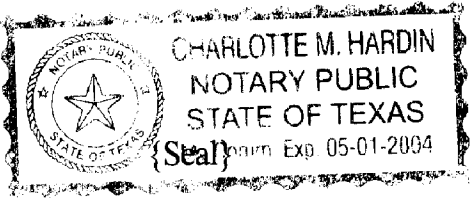
