

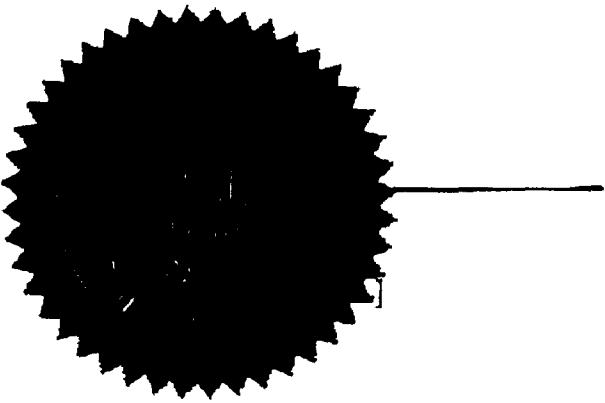

The effective date of this Assignment is June 6, 2002.


