RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS is made this 1st day of ~~April~~ ^{May}, 2003 by National Bank of Canada as agent for itself and the other lenders party to that certain Amended and Restated Credit Agreement dated March 2, 1999 ("NBC").

WHEREAS, reference is made to that certain Trademark Security Agreement dated July 31, 1996, recorded with the United States Patent and Trademark Office at Reel 1491, Frame 0274 on August 12, 1996 and that Amended and Restated Trademark Security Agreement dated March 3, 1999 recorded with the United States Patent and Trademark Office at Reel 1886, Frame 0117 on April 12, 1999 (collectively, the "Security Agreements"), each executed by Belding Hausman Incorporated, a Delaware corporation, having a mailing address at 1430 Broadway, New York, New York 10018 ("Belding Hausman") and NBC.

WHEREAS, in connection with the Security Agreements, Belding Hausman granted NBC a continuing security interest in the Trademark "Blair House", Serial No. 72-190,258, Registration No. 782,919, registered with the United States Patent and Trademark Office on January 5, 1965 (the "Blair House Trademark").

NOW THEREFORE, for good and valuable consideration, NBC hereby releases and terminates all security interests in and to Blair House Trademark granted to NBC under the Security Agreements.
