

IN WITNESS WHEREOF, the Seller has caused this Assignment of Trademark Registrations and Applications to be executed on the date first above written.





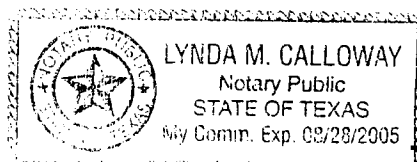
