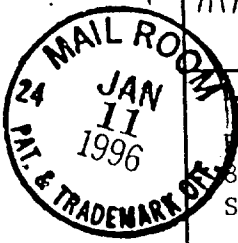

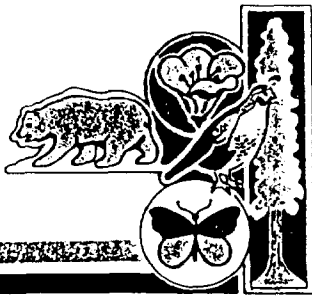



I am writing to you in the hope that an error can be corrected.


Specifically, on January 11, 1996, we filed a request for recordation of assignment of the merger of Ektelon (a California corporation) into Prince Sports Group, Inc. The change of name was to be recorded against eight trademark registrations.
