TERMINATION OF SECURITY INTEREST IN UNITED STATES TRADEMARKS

THIS TERMINATION OF SECURITY INTEREST IN UNITED STATES TRADEMARKS (this "Agreement") is executed as of this 17 day of April, 2003, by PNC BANK, NATIONAL ASSOCIATION, a national banking association, as Agent (in such capacity, the "Agent") for the financial institutions which are parties to the Credit Agreement described below (the "Lenders"), in favor of SWANK, INC., a Delaware corporation (the "Borrower")

WHEREAS, pursuant to the Revolving Credit and Security Agreement dated as of July 27, 1998, by and among the Borrower, the Lenders and the Agent (as amended, supplemented or otherwise modified from time to time, the "Credit Agreement"), the Lenders agreed to make revolving advances to, and to issue or participate in letters of credit for the account of, the Borrower, all upon the terms and subject to the conditions set forth therein;

WHEREAS, the Borrower, in connection therewith, did execute and deliver to Agent a certain Assignment of Security Interest in United States Trademarks (the "Security Agreement") dated July 27, 1998 granting to the Agent a security interest in the Trademarks as defined therein, including, without limitation, the trademarks listed on Schedule A hereto. The Security Agreement was recorded in the United States Patent and Trademark Office Assignment Branch at Trademark Reel 1789, Frames 0561-0578 on September 21, 1998; and

WHEREAS, all of the Borrower's obligations under the Credit Agreement have been satisfied in full and the Agent has agreed to terminate the security interest granted in the Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Agent does hereby terminate its security interest in and to the Trademarks, including, without limitation, the trademarks listed on Schedule A hereto, together with all the goodwill of the Borrower associated with and represented by the Trademarks and the applications relating thereto, the registrations thereof and the right (but not the obligation) to sue for past, present and future infringements, and the proceeds thereof, including without limitation, license royalties and proceeds of infringement suits.
