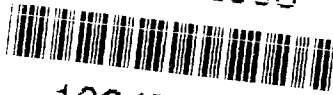



SECURITY AGREEMENT¹

TRADEMARKS

WHEREAS, each of Endocrine Sciences, Inc, a Delaware corporation, and The Esoterix Center for Infectious Disease, Inc. (herein referred to collectively as "Grantors"), have adopted, used and is using the trademarks listed across of such Grantor's name on the annexed Schedule 1, which trademarks are registered in the United States Patent and Trademark Office (the "Trademarks");

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, each Grantor does hereby further grant to Grantee a security interest in, and mortgage on, the Collateral to secure the prompt payment, performance and observance of the Secured Obligations.


Each Grantor does hereby further acknowledge and affirm that the rights and remedies of Grantee with respect to the assignment of, security interest in and mortgage on the Collateral made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.


