THIS DEED is made on the 19th day of February 2003

BETWEEN:

- (1) THE GOLDEN GROUP I, INC., a Colorado corporation having a principal business address at 601 16th Street #C-336, Golden, Colorado 80401, (the "Assignor");
- (2) JUPITERMEDIA CORPORATION, a Delaware corporation having a principal business address at 23 Old Kings Highway South, Darien, Connecticut 06820, United States of America (the "Assignee").

RECITALS:

- (A) The Assignor is the proprietor of the trade mark applications and registrations set out in the Schedule hereto (the "Trade Marks").
- (B) Pursuant to an asset purchase agreement dated 19 February 2003, made between the Assignor and the Assignee (the "Agreement"), the Assignor transferred a forty-nine and nine tenths percent (49.9%) undivided share in the title to the Trade Marks to the Assignee and retained a fifty and one tenth percent (50.1%) undivided share in the title to the Trade Marks. The parties now wish to enter into this Deed to confirm the transfer of the share in the title to the Trade Marks to the Assignee.

NOW THIS DEED WITNESSES as follows:

1. ASSIGNMENT

1.1 The Assignor irrevocably assigns to the Assignee by way of present assignment of a forty-nine and nine tenths percent (49.9%) undivided share in present and future rights, title and interest throughout the world (and shall procure the assignment to the Assignee of) a forty-nine and nine tenths percent (49.9%) undivided share of its entire legal (and, to the extent that it owns any, a forty-nine and nine tenths percent (49.9%) undivided share of the beneficial) right, title and interest of the Assignor in and to the Trade Marks (including any goodwill associated therewith) with full title guarantee, together with all accrued rights of action in relation to any infringement of the Trade

Marks, to hold the same unto the Assignee, its successors in title and assigns absolutely. The assignment is made with the intention that the Assignee will own that forty-nine and nine tenths per cent (49.9%) share to right and title (legal and beneficial) to the Trade Marks.

2. **FURTHER ASSURANCE**

2.1 The Assignor agrees to execute and procure at his cost the execution of any further documents and do and procure any such thing as the Assignee may reasonably require to ensure the rights to be assigned hereunder are fully vested in the Assignee and to enable the Assignee to become registered as the joint-proprietor of the Trade Marks and to secure the benefit of the rights hereby assigned.

3. **GOVERNING LAW AND JURISDICTION**

3.1 The validity, construction and performance of this Deed shall be governed by and construed in accordance with the law of England and Wales.

3.2 Each party irrevocably agrees to submit to the exclusive jurisdiction of the courts of England and Wales over any claim, dispute or matter arising under or in connection with this Deed.


