TRADEMARK TRANSFER AND ASSIGNMENT

THIS RELEASE is made as of this 10th day of November, 2003, by Deutsche Bank Trust Company Americas (successor in interest to Bankers Trust Company) ("DB") in favor of Essex Group, Inc., a Michigan corporation ("Essex"), Essex Technology, Inc., a Delaware corporation ("Technology"), Essex International Ltd., a foreign wholly-owned subsidiary of Essex ("International"), Temple Electrical Company Ltd., an indirect wholly owned subsidiary of Essex ("Electrical") and Superior Essex Communications LLC., a Delaware corporation (formerly Superior Telecommunications Inc.) ("Superior Essex"; Essex, Technology, Superior Essex, International and Electrical are referred to hereinafter collectively, jointly and severally, as the "Companies"). The Companies have satisfied their obligations under the Second Amended and Restated Security Agreement, dated November 30, 2001, made by Essex, Superior Essex and certain subsidiaries in favor of DB (the "Security Agreement") and under the Security Agreement, dated March 15, 2002, by and among Essex, International, Electrical and DB (the "Second Security Agreement").

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, DB hereby unconditionally and expressly releases, terminates, and extinguishes any and all of its right, title and interest in and to, and any and all liens and security interests it may have upon the trademarks listed on Exhibit A attached hereto and made part hereof and any other trademarks that may not be listed on Exhibit A, if any, to the extent that such rights were assigned to DB as collateral, which liens and security interests were established under and pursuant to that certain Security Agreement and the Second Security Agreement.

This Release shall be binding upon DB's legal representatives, assigns and successors. DB agrees to execute any and all such documents as reasonably requested by Essex, Technology, and/or Superior Essex to effectuate this release.
