

ASSIGNMENT OF UNITED STATES TRADEMARK REGISTRATIONS AND APPLICATIONS

WHEREAS, THE MEAD CORPORATION (hereinafter "Mead"), an Ohio corporation with offices at Courthouse Plaza, N.E., Dayton, Ohio 45463, is the owner of all right, title and interest in and to certain trademarks, and to United States trademark registrations and applications pertaining thereto;

WHEREAS, MEADWESTVACO PACKAGING SYSTEMS LLC (hereinafter "MPS"), a Delaware corporation with offices at One High Ridge Park, Stamford, Connecticut 06905, pursuant to an agreement effective the 31st day of December, 2002, has acquired certain assets of Mead comprising various businesses in which Mead has previously been engaged (hereinafter the "Asset Assignment"), as a result of which MPS is Mead's successor to such businesses;

WHEREAS, as part of said Asset Assignment, MPS is desirous of acquiring the entire right, title and interest in and to said trademarks, trademark registrations and applications;

NOW, THEREFORE, be it known that:

1. As used herein, the term "Trademark Registrations and Applications" shall include the United States trademark registrations and applications for registration set forth in Appendix A attached hereto and made a part hereof.
2. In consideration of the sum of One United States Dollar (US\$ 1.00) and other valuable consideration, receipt of which is hereby acknowledged, Mead hereby sells, assigns and transfers to MPS, its successors and assigns, the entire right, title and interest in and to the Trademark Registrations and Applications, along with any and all goodwill associated with the Trademark Registrations and Applications. Mead further acknowledges and confirms that, with respect to any Trademark Applications filed on the basis of Mead's intention to use such trademarks, and as a result of the Asset Assignment, MPS is Mead's successor to the businesses to which such marks pertain.
3. Mead further agrees that, upon the request of MPS, it will sign all papers, make all rightful oaths, and perform all acts that MPS may reasonably believe to be necessary in connection with the assignment made herein and the Trademark Registrations and Applications.
