## **TRADEMARKS ASSIGNMENT**

**THIS TRADEMARK ASSIGNMENT**, dated as of this 21<sup>st</sup> day of November, 2003 is made by Andrew Corporation, a Delaware corporation ("Assignor"), to Electronics Research, Inc., an Indiana corporation (the "Assignee").

### **BACKGROUND**

Assignor does hereby sell, grant, assign, transfer, convey and deliver to Assignee all of its right, title and interest in and to the Marks together with the goodwill of the business in connection with which the Marks are used throughout the world and including the subject matter of all claims which may be obtained therefrom for Assignee's own use and enjoyment, and for the use and enjoyment of its successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by the Assignor if this Assignment had not been made; together with the United States federal and state registrations and all foreign registrations for the Marks, all claims for damages by reason of past, present or future infringement or other unauthorized use of the Marks, with the right to sue for, and collect the same for its own use and enjoyment, and for the use and enjoyment of its successors, assigns, or other legal representatives.

Assignor authorizes and requests the Commissioner of Patents and Trademarks to record Assignee as the owner of its entire right, title and interest in and to the Marks, for the sole use and enjoyment of Assignee, its successors, assigns or other legal representatives. Assignor warrants that it has the full right to convey the entire interest herein assigned and that it has not executed, and will not execute, any agreement in conflict herewith.
