RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this "Release") is made as of May 20, 2003 ("Effective Date") by and between Muzak, LLC, formally known as Audio Communications Network, LLC., Muzak Holdings, LLC (collectively, "Grantor"), and Canadian Imperial Bank of Commerce ("Grantee").

WHEREAS, pursuant to the terms and conditions of that certain Trademark Security Agreement, dated as of March 18, 1999, as amended and modified by and between Grantor and Grantee (the "Trademark Security Agreement"), Grantor pledged, assigned and granted to Grantee a continuing first priority security interest in and lien on and right of set-off against all of its right, title and interest in and to its Trademarks (as defined in the Trademark Security Agreement), including without limitation the trademark registrations and applications set forth on Schedules A and B hereto (collectively, the "Trademarks") together with the goodwill associated therewith;

WHEREAS, Grantor and Grantee entered into the Trademark Security Agreement pursuant to the terms and conditions of that certain that certain Pledge and Security Agreement, dated as of March 18, 1999, as amended and modified by and between Grantor and Grantee (the "Pledge and Security Agreement")

WHEREAS, the Trademark Security Agreement and subsequent filings in respect thereof were recorded with the United States Patent and Trademark Office ("PTO") at Reel 1879 / Frame 0748 on April 2, 1999 and Reel 2523 / Frame 0683 on May 16, 2002 respectively;

AND WHEREAS, Grantor has paid all of its outstanding indebtedness to Grantee.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby terminates the Trademark Security Agreement, and hereby terminates, cancels, re-pledges, reassigns and releases any and all security interests it has against the Trademarks.

If and to the extent Grantee has acquired any right, title or interest to any of the Trademarks, it hereby assigns and transfers such rights, title or interest to Grantor.

Grantee shall take all further actions, and provide to Grantor and each of its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), requested by Grantor to more fully and effectively effectuate the purposes of this Release.
