**TERMINATION OF SECURITY INTEREST**

This **TERMINATION OF SECURITY INTEREST**, dated as of December 22, 2003, is made by Bank of America, N.A., as Collateral Agent (the "Secured Party").

**WHEREAS**, Medware Solutions, Inc. (the "Grantor") has granted a security interest in certain personal property to the Secured Party, including without limitation a security interest in certain trademarks, trademark registrations, trademark applications, patents and patent applications, ("Collateral"); and

4. all products and proceeds of the foregoing, including, without limitation, any claim by the Grantor against third parties for past, present or future (i) infringement of any Collateral (ii) dilution of any trademark or (iii) injury to the goodwill associated with any trademark.
