# TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS

- 2. <u>Release of Security Interest</u>: The Collateral Agent hereby terminates, releases, discharges, quitclaims and relinquishes its Security Interest in the Trademark Collateral, and any right, title or interest of the Collateral Agent in such Trademark Collateral shall hereby cease and become void.


