RELEASE OF SECURITY INTERESTS  
IN INTELLECTUAL PROPERTY

THIS RELEASE, dated as of the 10<sup>th</sup> day of May, 2000, releases the security interest in the "Collateral" (as defined below) created by the Intellectual Property Security Agreement (the "Security Agreement"), dated as of March 28, 1996, among Johnston Industries, Inc., Johnston Industries Alabama, Inc. (formerly known as Opp and Micolos Mills, Inc.), J.I. Georgia, Inc. (formerly known as T.J. Beall Company), and Johnston Industries Composite Reinforcements, Inc. (collectively, the "Grantors" and individually, a "Grantor") in favor of The Chase Manhattan Bank (successor by merger to The Chase Manhattan Bank, N.A.), as agent ("Agent") on behalf and for the benefit of each of the lenders identified therein (the "Banks"). The term "Collateral" as used herein shall mean the Patents, Trademarks, Copyrights and other Intellectual Property listed on the attached Schedule A, including the following:

(i) all patents and applications for letters patent throughout the world, including, but not limited to, each patent and patent application referred to in Schedule A hereto, all reissues, divisions, continuations, continuations-in-part, extensions, renewals and reexaminations of any of the foregoing, all rights corresponding thereto throughout the world, and all proceeds of the foregoing including, but not limited to, license, royalties, income, payments, claims, damages, and proceeds of suit; and

(ii) all trademarks, trade names, corporate names, company names, business names, fictitious business names, trade styles, service marks, certification marks, collective marks, logos, other source of business identifiers, designs and general intangibles of a like nature, all registrations and applications for any of the foregoing including, but not limited to the trademark and servicemark registrations and applications referred to in Schedule A hereto, all extension or renewals of any of the foregoing; all of the goodwill of the business connected with the use of and symbolized by the foregoing; the right to sue for past infringement or dilution of any of the foregoing or for any injury to goodwill, and all proceeds of the foregoing, including, without limitation, license royalties, income, payments, claims, damages, and proceeds of suit; and

(iii) all copyrights, copyright registrations and applications for copyright registrations, including, without limitation, all renewals and extensions thereof, the right to recover for all past, present and future infringements thereof and all other rights of any kind whatsoever accruing thereunder or pertaining thereto; and

(iv) all inventions, processes, production methods, proprietary information, know-how and trade secrets; and

(v) all licenses or user or other agreements granted to any Grantor with respect to any of the foregoing (other than any such license or user or other agreement which by its terms, or by operation of law, prohibits the assignability thereof), in each case whether now or hereafter

owned or used including, without limitation, the licenses or other agreements with respect to any copyrights, Patent or Trademarks; and

(vi) all information, customer lists, identification of suppliers, sales data, data, plans, specifications, designs, drawings, recorded knowledge, test reports, manuals, materials standards, processing standards, performance standards, catalogs, computer and automatic machinery software and programs; and

(vii) all accounting information and all media in which or on which any information or knowledge or data or records may be recorded or stored and all computer programs used for the compilation or printout of such information, knowledge, records or data (other than computer programs which are not owned by any Grantor and which are subject to a restriction on the assignability thereof); and

(viii) all causes of action, claims and warranties now or hereafter owned or acquired by any Grantor in respect of any of the items listed above.

WHEREAS, the Grantors granted a security interest in the "Collateral," as set forth in Schedule A, to the Agent on behalf and for the benefit of each of the Banks, pursuant to the Security Agreement; and

WHEREAS, the Agent, as agent for the Banks, is now releasing its security interest in the "Collateral," as set forth in Schedule A.

NOW, THEREFORE, the Agent, as agent for the Banks, hereby agrees as follows:

1. The Agent hereby releases any and all security interest in the "Collateral," as set forth in Schedule A, granted by the Security Agreement, and hereby terminates its rights under the Security Agreement.

2. The Agent hereby acknowledges the sufficiency and completeness of this document to terminate the security interest in the "Collateral," as set forth in Schedule A.

IN WITNESS WHEREOF, the Agent on behalf and for the benefit of each of the Banks hereby executes this Release as of the 10<sup>th</sup> day of May, 2000.
