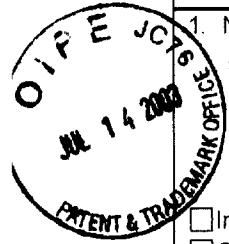

RELEASE OF SECURITY INTEREST

WHEREAS, TransMontaigne Inc., a Delaware corporation, with offices at 2750 Republic Plaza, 370 17th Street, Denver, CO 80202, on February 28, 2003 granted a security interest in the federal trademark Registration Nos. 2,434,769 and 2,424,751 (collectively the "Marks") to UBS AG, Stamford Branch, in connection with which a security agreement was recorded with the United States Patent and Trademark Office on April 3, 2003 and a term loan security agreement and perfection certificate were recorded with the United States Patent and Trademark Office on April 30, 2003. The United States Patent and Trademark Office has not yet assigned Reel/Frame Nos. to either filing.

NOW THEREFORE, for good and valuable consideration paid by Assignee, receipt of which is hereby acknowledged, Assignor hereby releases the mortgage, pledge, and security interest in and to the Marks, releases all other rights it may have under said security agreement, term loan security agreement and perfection certificate with respect to the Marks, and cancels such agreement with respect to the Marks, effective as of the date written below.
