RELEASE OF SECURITY INTEREST

This **RELEASE OF SECURITY INTEREST** ("Release") is given as of this 5th day of January, 2004 by JPMorgan Chase Bank, formerly known as The Chase Manhattan Bank, a New York banking corporation ("Chase"), located at 270 Park Avenue, New York, NY, 10017, in favor of Houston NFL Holdings, L.P., a Delaware limited partnership, located at Reliant Stadium, Two Reliant Park, Houston, Texas, 77054.

WHEREAS, pursuant to a Team Security Agreement, dated January 3, 2001, by and among Houston NFL Holdings, L.P., certain of its subsidiaries, and Chase, as the collateral agent (as amended and in effect, the "Security Agreement"), Houston NFL Holdings, L.P. bargained, sold, conveyed, assigned, set over, mortgaged, pledged, hypothecated, transferred and granted a security interest in all of Houston NFL Holdings, L.P.'s right, title, and interest in, to and under the Collateral, (as defined in the Security Agreement), including the trademarks set forth on Schedule A attached hereto (the "Trademarks"), to Chase as collateral agent for the ratable benefit of the Secured Parties (as defined in the Security Agreement), which security interest was recorded in the United States Patent and Trademark Office on March 26, 2001 at Reel 2264/Frame 0058; and


