ASSIGNMENT OF TRADEMARK REGISTRATION



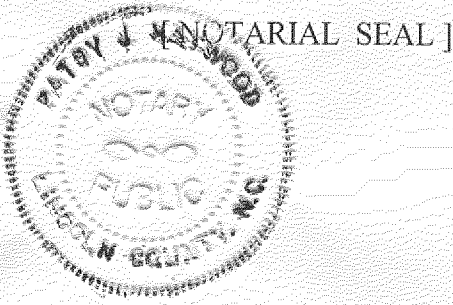
