

**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This Release of Security Interest in Trademarks is made on this 25<sup>th</sup> day of February, 2004 by AmSouth Bank with its principal place of business at 550 Metroplex Dr. Nashville, TN 37211 (the "Secured Party").

WHEREAS, SXC Health Solutions, Inc., a Texas corporation, with its principal place of business at 2505 S. 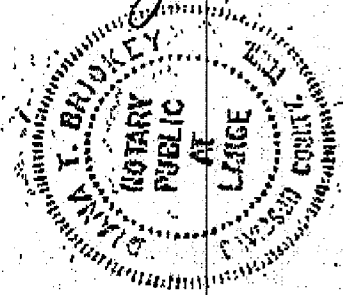
