

GRANT OF SECURITY INTEREST

WHEREAS, HOUGHTON TECHNICAL CORP., a Delaware corporation, (herein referred to as "Debtor"), owns all right, title and interest in and to the trademarks listed on the annexed Schedule A (the "Trademarks");

WHEREAS, Debtor is a wholly-owned subsidiary of HOUGHTON INTERNATIONAL INC. ("Borrower");

WHEREAS, Borrower is a party to that certain Credit Agreement dated February 3, 2004, by and between Borrower, CITIZENS BANK OF PENNSYLVANIA as Lead Arranger, Administrative Agent and Issuer ("Agent") and the Lenders referred to therein (as may be amended, supplemented, restated or otherwise modified from time to time, the "Credit Agreement"); and

WHEREAS, pursuant to a Security Agreement dated March 12, 2004 (as may be amended, supplemented, restated or otherwise modified from time to time, the "Security Agreement"), Debtor has granted to Agent, for the benefit of the Secured Parties (as that term is defined in the Credit Agreement), a security interest in all right, title and interest of Debtor in and to the Trademarks, together with the goodwill of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all past, present and future causes of action which may exist by reason of infringement thereof (the "Collateral"), to secure the payment, performance and observance of the Secured Obligations (as that term is defined in the Credit Agreement).

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Debtor does hereby grant to Agent a security interest in the Collateral to secure the prompt payment, performance and observance of the Secured Obligations.

Debtor does hereby further acknowledge and affirm that the rights and remedies of Agent with respect to the security interest in the Collateral made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.

IN WITNESS WHEREOF, Debtor has caused this Grant of Security Interest to be duly executed by its officer thereunto duly authorized as of the 12~~th~~ day of March, 2004.
