TRADEMARK ASSIGNMENT

This Assignment granted on this ^{APRIL} 27 day of ~~March~~, 2001, by FINOVA CAPITAL CORPORATION, a Delaware corporation ("Assignor") and ELCO FILTRATION CO. ("Assignee"), as follows:

WITNESSETH

WHEREAS, GWC VALVE COMPANY, INC., a California corporation (the "Company") executed a Grant of Security Interest - Trademarks, dated July 10, 1998, in favor of Assignor, duly recorded on July 30, 1998, at Trademark Reel 1762, Frame 256 in the United States Patent and Trademark Office (the "Agreement"), and a Special Power of Attorney, dated July 10, 1998 (the "Power of Attorney"), pursuant to which the Company assigned and granted to Assignor a security interest in and to all of the Company's right, title and interest in and to certain trademarks, service marks, trade names and applications therefor, as more specifically listed on the schedules and exhibits attached thereto (the "Marks") and the goodwill associated therewith.

WHEREAS, the Assignor wishes to assign all of its right, title and interest in and to the Marks to the Assignee and to assign all of Assignor's liens, claims and encumbrances respecting the Marks, and the goodwill associated therewith, "where is" and "as is," without any representation or warranty of any kind or nature, whether expressed or implied (collectively, the "Rights").

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Assignor hereby assigns transfers and delivers its entire right, title and interest, including all rights of action and damages for past infringement, in and to the Marks and the Rights, together with the goodwill of the business in connection with which said Marks are used or as symbolized thereby.
