**(TRADEMARKS)**



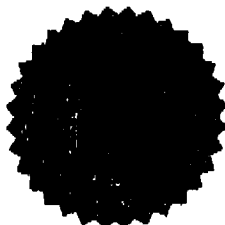
