PATENT AND TRADEMARK SECURITY AGREEMENT

This PATENT AND TRADEMARK SECURITY AGREEMENT, dated as of August 15, 2003 (this "Patent and Trademark Security Agreement"), by each of the parties listed on the signature pages hereof and those additional entities that hereafter become parties hereto by executing the form of Supplement attached hereto as Annex 1, as grantors (collectively, "Grantors", and individually, each a "Grantor"), in favor of WELLS FARGO FOOTHILL, INC., a California corporation, as administrative agent and collateral agent for the Lenders (as defined below) ("Agent").

WITNESSETH:

WHEREAS, Amerco, a Nevada corporation, and Amerco Real Estate Company, a Nevada corporation, as borrowers, debtors and debtors-in-possession (collectively, the "Borrowers"), Agent, and the Lenders (as defined in the hereinafter defined Loan Agreement) are parties to that certain Senior Secured, Super-Priority Debtor-in-Possession Loan and Security Agreement dated as of even date herewith (as the same may be amended, restated, supplemented or otherwise modified from time to time, the "Loan Agreement"; capitalized terms used herein and not otherwise defined shall have the meanings ascribed to such terms in the Loan Agreement or Guarantor Security Agreement (as defined below), as applicable), pursuant to which the Lender Group has agreed to make Advances, issue Letters of Credit and make other extensions of credit to the Borrowers from time to time pursuant to the terms and conditions thereof and the other Loan Documents; and

WHEREAS, as an inducement to Agent and the Lenders to execute and deliver the Loan Agreement and to extend the loans and other financial accommodations to the Borrowers thereunder, the Guarantors have agreed to enter into (i) that certain Guaranty dated as of even date herewith, given by the Guarantors (other than U-Haul Co. of Arizona, U-Haul Co. of Hawaii and U-Haul Co. of Alaska) to Agent (the "Master Guaranty"), (ii) that certain Guaranty dated as of even date herewith, given by U-Haul Co. of Arizona, U-Haul Co. of Hawaii and U-Haul Co. of Alaska to Agent (the "Vehicle Subsidiaries Guaranty"; together with the Master Guaranty, collectively, the "Guaranty"), and (iii) that certain Guarantor Security Agreement dated as of even date herewith, among the Guarantors and Agent (the "Guarantor Security Agreement"); and

WHEREAS, each Grantor is a Borrower or a direct or indirect Subsidiary of a Borrower, and each Grantor has determined that it will realize substantial direct and indirect benefits as a result of the loans and other financial accommodations extended to the Borrowers pursuant to the Loan Agreement, and such Grantor's execution, delivery and performance of this Patent and Trademark Security Agreement are within such Grantor's corporate or other purposes and are in the best interests of the Grantors; and

WHEREAS, it is a condition precedent to the execution and delivery of the Loan Agreement by Agent and the Lenders and the extension of the loans and other financial accommodations to the Borrowers thereunder that each Grantor execute and deliver this Patent

and Trademark Security Agreement to Agent and grant a security interest to Agent in order to ensure and secure the prompt performance of all covenants, agreements and liabilities of the Loan Parties under the Loan Documents and the prompt repayment of any and all now existing or hereafter arising Obligations and other obligations of the Loan Parties under the Loan Documents (including, without limitation, any interest, fees or other charges in respect of the Loan Agreement, the other Loan Documents that would accrue but for the filing of an Insolvency Proceeding with respect to any Borrower, whether or not such claim is allowed in such Insolvency Proceeding);

NOW, THEREFORE, in consideration of the premises and mutual covenants herein contained and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Grantor hereby agrees as follows:

1. DEFINED TERMS. The following terms shall have the following respective meanings:

“Patent” means all of the following in which any Grantor now holds or hereafter acquires any right, title or interest: (a) all patents of the United States or any other country, all registrations and recordings thereof, and all applications for patents of the United States, Canada or any other country, including all registrations, recordings and applications in the PTO or in any similar office or agency of the United States, Canada or any State, Province or Territory thereof, or any other country or any political subdivision thereof; (b) all licenses, fees, royalties, income, damages and payments now and hereafter due and/or payable under and with respect thereto, including, without limitation, payments under all licenses entered into in connection therewith and damages and payments for past or future infringements thereof; (c) the right to sue for past, present and future infringements thereof; and (d) all of such Grantor’s rights corresponding thereto throughout the world.

“Patent Licenses” means any and all rights under or interest in any written agreement now owned or hereafter acquired by any Grantor granting any right to make, use or sell any invention subject to an effective patent, whether such Grantor is a licensee or licensor under any such license agreement, including, without limitation, the license agreements listed on Schedule I attached hereto and made a part hereof, and the right to use the foregoing in connection with the enforcement of the Lender Group’s rights under the Loan Agreement and the Guarantor Security Agreement, as applicable, including without limitation, the right to prepare for sale and sell any and all Inventory (as defined in the Loan Agreement and the Guarantor Security Agreement) and Equipment (as defined in the Loan Agreement and the Guarantor Security Agreement) now or hereafter owned by such Grantor and now or hereafter covered by such licenses.

“PTO” means the United States Patent and Trademark Office.

“Trademark” means all of the following in which any Grantor now holds or hereafter acquires any right, title or interest: (a) all trademarks, trade names, corporate names, business names, trade styles, service marks, logos, other source or business identifiers, prints and labels on which any of the foregoing have appeared or appear, designs and general intangibles of like nature (whether registered or unregistered), all registrations and recordings thereof, and all

applications in connection therewith in the United States, Canada or any other country, including all registrations, recordings and applications in the PTO or in any similar office or agency of the United States, Canada or any State, Province or Territory thereof, or any other country or any political subdivision thereof; (b) all licenses, fees, royalties, income, damages and payments now and hereafter due and/or payable under and with respect thereto, including, without limitation, payments under all licenses entered into in connection therewith and damages and payments for past or future infringements or dilutions thereof; (c) the right to sue for past, present and future infringements and dilutions thereof; and (d) all of such Grantor's rights corresponding thereto throughout the world.

"Trademark Licenses" means any and all rights under or interest in any written agreement now owned or hereafter acquired by any Grantor granting any right to use any Trademark, whether such Grantor is a licensee or licensor under any such license agreement, including, without limitation, the license agreements listed on Schedule I attached hereto and made a part hereof, and the right to use the foregoing in connection with the enforcement of the Lender Group's rights under the Loan Agreement and the Guarantor Security Agreement, as applicable, including without limitation, the right to prepare for sale and sell any and all Inventory and Equipment now or hereafter owned by such Grantor and now or hereafter covered by such licenses.

2. GRANT OF SECURITY INTEREST IN PATENT AND TRADEMARK COLLATERAL. To secure the complete and timely payment, performance and satisfaction of (a) the Obligations and the other covenants, agreements and liabilities of the Borrowers under the Loan Agreement and (b) the obligations of Grantors under the Loan Documents, and any extensions, renewals or amendments to any of the foregoing, however created, acquired, arising or evidenced, whether direct or indirect, absolute or contingent, now or hereafter existing, or due or to become due, including, without limitation, any interest on any of the foregoing (including, without limitation, any interest, fee or other charge in respect of the Loan Agreement and the other Loan Documents that would accrue but for the filing of any Insolvency Proceeding (including but not limited to those applicable to Grantors located in a foreign jurisdiction) with respect to any Grantor, whether or not such claim is allowed in such Insolvency Proceeding), plus attorneys' fees and expenses if the obligations represented by this Patent and Trademark Security Agreement are collected by law, through an attorney-at-law, or under advice therefrom (all of the foregoing now existing or hereafter arising obligations being referred to, collectively, as the "Secured Obligations"), each Grantor hereby grants to Agent, for the benefit of the Lender Group and Bank Products Providers, a continuing first priority security interest in all of such Grantor's right, title and interest in, to and under the following, whether presently existing or hereafter created or acquired (collectively, the "Patent and Trademark Collateral"):

(a) all of its Patents and Patent Licenses to which it is a party, including those referred to on Schedule I hereto;

(b) all of its Trademarks and Trademark Licenses to which it is a party, including those referred to on Schedule II hereto;

(c) all reissues, continuations, continuations-in-part or extensions of the foregoing;

(d) the goodwill of such Grantor's business symbolized by the foregoing and connected therewith; and

(e) all products and proceeds of the foregoing, including, without limitation, license royalties and any claim by such Grantor against third parties for past, present or future (i) infringement of any Patent or Patent licensed under any Patent License, (ii) infringement or dilution of any Trademark or Trademark licensed under any Trademark License or (iii) injury to the goodwill associated with any Patent, Patent licensed under any Patent License, Trademark, or Trademark licensed under any Trademark License.

Notwithstanding the foregoing provisions of this Section 2, the grant of a security interest in the Patent Licenses and the Trademark Licenses shall not include any license agreement in effect as of the date hereof which by its terms prohibits the grant of the security interest contemplated by this Patent and Trademark Security Agreement or the assignment of Grantor's rights under the Patent Licenses and the Trademark Licenses; provided, however, that upon the termination of such prohibitions for any reason whatsoever, the provisions of this Section 2 shall be deemed to apply thereto automatically; and provided, further, that such Grantor shall fully disclose to Agent all such prohibitions contained in the Patent Licenses and the Trademark Licenses listed on Schedule I and shall promptly notify Agent upon the termination of such prohibitions.

3. SECURITY AGREEMENT. The security interests granted pursuant to this Patent and Trademark Security Agreement are granted in conjunction with the security interests granted to Agent, for the benefit of the Lender Group and Bank Product Providers, pursuant to the Loan Agreement and the Guarantor Security Agreement. Each Grantor hereby acknowledges and affirms that the rights and remedies of Agent with respect to the security interest in the Patent and Trademark Collateral made and granted hereby are more fully set forth in the Loan Agreement and the Guarantor Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.

4. RESTRICTIONS ON FUTURE AGREEMENTS. No Grantor shall, without Agent's prior written consent, which consent shall not be unreasonably withheld, enter into any agreement, including, without limitation, any license agreement, which is inconsistent with this Patent and Trademark Security Agreement, and each Grantor further agrees that it will not take any action, and will use its best efforts not to permit any action to be taken by others subject to its control, including, without limitation, licensees, or fail to take any action, which would in any material respect adversely affect the validity or enforcement of the rights granted to Agent under this Patent and Trademark Security Agreement or the rights associated with the Patent and Trademark Collateral. Notwithstanding the foregoing provision, Grantor shall not be restricted in its ability to enter into non-exclusive licenses and similar agreements in the ordinary course of business, consistent with its past practices to the extent permitted by the Loan Agreement and the other Loan Documents.

5. NEW PATENT AND TRADEMARK COLLATERAL. Each Grantor restates the representations and warranties made by such Grantor in the Loan Agreement and the Guarantor Security Agreement, as applicable, with respect to the Patent and Trademark

Collateral. If, prior to the termination of the Loan Agreement and the Guarantor Security Agreement, and pursuant to the provisions thereof, any Grantor shall (i) obtain rights to or become entitled to the benefit of any patent or patent application or any reissue, division, continuation, renewal, extension or continuation-in-part of any Patent or any improvement on any Patent, (ii) obtain rights to or become entitled to the benefit of any new trademarks, trade names, registered trademarks, trademark applications, service marks, registered service marks or service mark applications, (iii) obtain rights to or become entitled to the benefit of any new license agreements, whether as licensee or licensor, or license renewals, or (iv) enter into any new license agreement, the provisions of this Patent and Trademark Security Agreement shall automatically apply thereto (to the extent permitted by third party licensors or licensees under agreements in connection with the granting of licenses under such agreements). Each Grantor shall cause each such new Patent or Trademark or application therefor to be registered with the appropriate filing offices, including, without limitation, the PTO, in a manner sufficient to impart constructive notice of such Grantor's ownership thereof. Each Grantor hereby authorizes Agent to modify this Patent and Trademark Security Agreement unilaterally (x) by amending Schedule I to include any future patents and patent applications that are Patents under this Patent and Trademark Security Agreement, or to include any future license agreements that are Patent Licenses under this Patent and Trademark Security Agreement (to the extent permitted by licensors under agreements in connection with the granting of licenses under such agreements), (y) by amending Schedule II to include any future trademarks, trade names, registered trademarks, trademark applications, service marks, registered service marks and service mark applications that are Trademarks under this Patent and Trademark Security Agreement, or to include any future license agreements that are Trademark Licenses under this Patent and Trademark Security Agreement (to the extent permitted by licensors under agreements in connection with the granting of licenses under such agreements), or (z) by filing, in addition to and not in substitution for this Patent and Trademark Security Agreement, a duplicate original of this Patent and Trademark Security Agreement containing on Schedule I thereto, as the case may be, such future patents, patent applications and future license agreements and containing on Schedule II thereto, as the case may be, such future trademarks, trade names, registered trademarks, trademark applications, service marks, registered service marks, service mark applications and future license agreements.

6. FURTHER ASSIGNMENTS AND SECURITY INTEREST. Each Grantor agrees (a) not to sell or assign any of its interests in, or grant any security interest in or license under, the Patents and the Trademarks in favor of any Person other than Agent without the prior and express written consent of Agent and (b) not to sell or assign its interests in the Patent Licenses and Trademark Licenses without the prior and express written consent of Agent; provided, however, that, to the extent permitted by the Loan Agreement, such Grantor shall be permitted to grant non-exclusive licenses in the ordinary course of business for the use of the Grantor's Patents and Trademarks.

7. DUTIES OF EACH GRANTOR. Each Grantor shall have the duty to take all reasonable and necessary action to preserve and maintain all of such Grantor's rights in the Patent and Trademark Collateral. Each Grantor further agrees to make reasonable commercial efforts (i) not to abandon any Patent and Trademark Collateral that is necessary or economically desirable in the operation of such Grantor's business without the prior written consent of Agent, and (ii) to use its best efforts to maintain in full force and effect the Patent and Trademark

Collateral that is or shall be necessary or economically desirable in the operation of such Grantor's business. Any expenses incurred in connection with the foregoing shall be borne by the appropriate Grantor. Agent shall have no duty with respect to the Patent and Trademark Collateral. Without limiting the generality of the foregoing, Agent shall not be under any obligation to take any steps necessary to preserve rights in the Patent and Trademark Collateral against any other Person, but Agent may do so at its option from and after the occurrence and during the continuance of an Event of Default, and all expenses incurred in connection therewith (including, without limitation, fees and expenses of attorneys actually incurred and the fees and expenses of other professionals for Agent) shall be for the sole account of Grantors and shall be added to the Secured Obligations.

8. INDEMNIFICATION BY GRANTORS. Each Grantor hereby agrees to indemnify and hold harmless the Lender Group for any and all liabilities, obligations, losses, damages, penalties, actions, judgments, suits, costs, expenses or disbursements (including, without limitation, attorneys' fees actually incurred) of any kind whatsoever which may be imposed on, incurred by or asserted against Agent or any other member of the Lender Group in connection with or in any way arising out of or related to any or all of the Patent and Trademark Collateral, unless, with respect to any of the above, such Person to be indemnified is judicially determined to have acted or failed to act with gross negligence or willful misconduct. The indemnification in this paragraph shall survive the termination of this Patent and Trademark Security Agreement.

9. AGENT'S RIGHT TO SUE. From and after the occurrence and during the continuance of an Event of Default, Agent shall have the right, but shall not be obligated, to bring suit in its own name to enforce the Patent and Trademark Collateral and, if Agent shall commence any such suit, the appropriate Grantor shall, at the request of Agent, do any and all lawful acts and execute any and all proper documents reasonably required by Agent in aid of such enforcement. The appropriate Grantor shall, upon demand, promptly reimburse Agent for all costs and expenses incurred by Agent in the exercise of its rights under this Section 9 (including, without limitation, fees and expenses of attorneys actually incurred and the fees and expenses of other professionals for Agent).

10. WAIVERS. Agent's failure, at any time or times hereafter, to require strict performance by any Grantor of any provision of this Patent and Trademark Security Agreement shall not waive, affect or diminish any right of Agent thereafter to demand strict compliance and performance therewith nor shall any course of dealing between any Grantor and Agent have such effect. No exercise by Agent of one right or remedy shall be deemed an election, and no waiver by Agent of any Event of Default shall be deemed a continuing waiver. No delay by Agent shall constitute a waiver, election, or acquiescence by it. Agent shall not, by any act, delay, omission or otherwise, be deemed to have waived any of its rights or remedies hereunder, unless such waiver is in writing signed by Agent and directed to the Grantor to which such waiver applies, and then only to the extent therein set forth. A waiver by Agent of any right or remedy on any occasion shall not be construed as a bar to the exercise of any such right or remedy that it would otherwise have had on any other occasion.

11. SEVERABILITY OF PROVISIONS. Each provision of this Patent and Trademark Agreement shall be severable from every other provision of this Patent and

Trademark Agreement for the purpose of determining the legal enforceability of any specific provision.

12. MODIFICATION. Neither this Patent and Trademark Security Agreement nor any provision hereof may be altered, amended or modified in any way, except as specifically provided in Section 5 or in a written instrument signed by the parties hereto.

13. POWER OF ATTORNEY; CUMULATIVE REMEDIES.

(a) Each Grantor hereby irrevocably designates, constitutes and appoints Agent (and all officers and agents of Agent designated by Agent in its sole and absolute discretion) as such Grantor's true and lawful attorney-in-fact, and authorizes Agent and any of Agent's designees, in such Grantor's or Agent's name, upon the occurrence and during the continuation of an Event of Default, to take any action and execute any instrument necessary or reasonably advisable to accomplish the purposes of this Patent and Trademark Security Agreement, including, without limitation, to (i) endorse such Grantor's name on all applications, documents, papers and instruments necessary or desirable for Agent in the use of the Patent and Trademark Collateral, (ii) assign, pledge, convey or otherwise transfer title in or dispose of the Patent and Trademark Collateral to any Person, (iii) grant or issue any exclusive or nonexclusive license under the Patent and Trademark Collateral to any Person, and (iv) take any other actions with respect to the Patent and Trademark Collateral as Agent deems in its best interest for the payment of the Secured Obligations. Each Grantor hereby ratifies all that such attorney shall lawfully do or cause to be done by virtue hereof. This power of attorney is coupled with an interest and shall be irrevocable until this Patent and Trademark Security Agreement is terminated. Each Grantor acknowledges and agrees that this Patent and Trademark Security Agreement is not intended to limit or restrict in any way the rights and remedies of Agent or any other member of the Lender Group under the Loan Agreement, the Guarantor Security Agreement or any other Loan Document, but rather is intended to facilitate the exercise of such rights and remedies.

(b) Agent shall have, in addition to all other rights and remedies given it by the terms of this Patent and Trademark Security Agreement, all rights and remedies allowed by law and the rights and remedies of a secured party under the Uniform Commercial Code as enacted in any jurisdiction in which the Patent and Trademark Collateral may be located or deemed located. Upon the occurrence and during the continuance of an Event of Default and the election by Agent to exercise any of its rights and remedies under Section 9-610, Section 9-620 or other provisions of the Uniform Commercial Code as in effect in any jurisdiction, with respect to the Patent and Trademark Collateral, each Grantor agrees to assign, convey and otherwise transfer title in and to the Patent and Trademark Collateral, to Agent or any transferee of Agent and to execute and deliver to Agent or any such transferee all such agreements, documents and instruments as may be necessary, in Agent's sole discretion, to effect such assignment, conveyance and transfer. All of Agent's rights and remedies with respect to the Patent and Trademark Collateral, whether established hereby, by the Loan Agreement, the Guarantor Security Agreement or by any other agreements or by law, shall be cumulative and may be exercised separately or concurrently. Notwithstanding anything set forth

herein to the contrary, it is hereby expressly agreed that upon the occurrence and during the continuance of an Event of Default, Agent may exercise any of the rights and remedies provided in this Patent and Trademark Security Agreement, the Loan Agreement or any of the other Loan Documents. To the extent permitted by applicable law, each Grantor agrees that any notification of intended disposition of any of the Patent and Trademark Collateral required by law shall be deemed reasonably and properly given if given at least ten (10) days before such disposition; provided, however, that Agent may give any shorter notice that is commercially reasonable under the circumstances.

14. NEW SUBSIDIARIES. Pursuant to, and subject to the terms of, Section 7.13(b) of the Loan Agreement, Grantors may form any new Subsidiary or acquire any direct or indirect Subsidiary after the Closing Date so long as at the time of the formation of any such direct or indirect Subsidiary of any Grantor, such new Subsidiary enters into this Patent and Trademark Security Agreement by executing and delivering in favor of Agent an instrument in the form of Annex 1 attached hereto. Upon the execution and delivery of Annex 1 by such new Subsidiary, such new Subsidiary shall become a Grantor hereunder with the same force and effect as if originally named as a Grantor herein. The execution and delivery of any instrument adding an additional Grantor as a party to this Patent and Trademark Security Agreement shall not require the consent of any Grantor hereunder. The rights and obligations of each Grantor hereunder shall remain in full force and effect notwithstanding the addition of any new Grantor hereunder.

15. SUCCESSORS AND ASSIGNS. This Patent and Trademark Security Agreement shall bind and inure to the benefit of the respective successors and assigns of each of the parties hereto; provided, however, that Grantors may not assign this Patent and Trademark Security Agreement or any rights or duties hereunder without Agent's prior written consent and any prohibited assignment shall be absolutely void *ab initio*. No consent to assignment by Agent shall release any Grantor from its obligations to Agent or any other member of the Lender Group. Agent may assign this Patent and Trademark Security Agreement and the other Loan Documents and its rights and duties hereunder and thereunder.

This validity of this Patent and Trademark Security Agreement, the construction, interpretation, and enforcement hereof and the rights of the parties hereto with respect to all matters arising hereunder or related hereto shall be determined under, governed by, and construed in accordance with the laws of the State of New York.

17. NOTICES. All notices or other communications hereunder shall be given in the form and manner and to the addresses set forth in the Loan Agreement or the Guarantor Security Agreement, as applicable.

18. SECTION HEADINGS. Headings and numbers have been set forth herein for convenience only. Unless the contrary is compelled by the context, everything contained in each Section applies equally to this entire Patent and Trademark Security Agreement.

19. EXECUTION IN COUNTERPARTS. This Patent and Trademark Security Agreement may be executed in any number of counterparts and by different parties on

separate counterparts, each of which, when executed and delivered, shall be deemed to be an original, and all of which, when taken together, shall constitute but one and the same agreement. Delivery of an executed counterpart of this Patent and Trademark Security Agreement by telefacsimile shall be equally as effective as delivery of an original executed counterpart of this Patent and Trademark Security Agreement.

20. SURVIVAL OF PROVISIONS. All representations, warranties and covenants of each Grantor contained herein shall survive the execution and delivery of this Patent and Trademark Security Agreement.

21. INTEGRATION. This Patent and Trademark Security Agreement, together with the other Loan Documents, reflects the entire understanding of the parties with respect to the transactions contemplated hereby and shall not be contradicted or qualified by any other agreement, oral or written, before the date hereof.

22. EFFECTIVENESS. This Patent and Trademark Security Agreement shall become effective on the date and year first written above.



In furtherance of the foregoing, New Grantor, as security for the payment and performance in full of the Secured Obligations, does hereby grant, assign, and pledge to Agent, for the benefit of the Lender Group and Bank Product Providers, a security interest in all Patent and Trademark Collateral of New Grantor, including, without limitation, all of its Patents and the Patent Licenses to which it is a party referred to on Schedule I hereto and all of its Trademarks and the Trademark Licenses to which it is a party referred to on Schedule II hereto, and all additions thereto and replacements thereof and all other property of New Grantor whether now or hereafter created, acquired or reacquired, to secure the full and prompt payment of the Secured Obligations, including, without limitation, any interest thereon, plus attorneys' fees actually incurred and expenses if the Secured Obligations represented by the Patent and Trademark Security Agreement are collected by law, through an attorney-at-law, or under advice therefrom.
