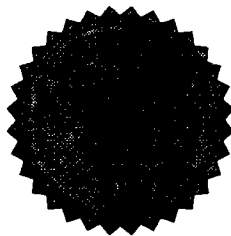

CERTIFICATE OF INCORPORATION

Dowd certifies that he is the Assistant Secretary of IMC Chemicals Sales Inc., a Delaware corporation (the "*Corporation*") and that the Certificate of Incorporation of the Corporation is hereby amended in accordance with Section 242 of the General Corporation Law of the State of Delaware (the "*DGCL*") and adopted by the sole director of the Corporation, to read as follows in full:

FIRST: That the Certificate of Incorporation of the Corporation be, and hereby is, amended by deleting Article First in its entirety and substituting in lieu thereof a new Article First to read as follows:

"FIRST: The name of the Corporation is Searles Valley Minerals Inc."

SECOND: That the sole director of the Corporation approved the foregoing amendment by unanimous written consent pursuant to the provisions of Sections 141(f) and 242 of the DGCL and directed that such amendment be submitted to the stockholders of the Corporation entitled to vote thereon for their consideration, approval and adoption thereof.

THIRD: That the stockholders entitled to vote thereon approved the foregoing amendment by written consent of its majority in accordance with Sections 228 and 242 of the DGCL.
