ASSIGNMENT

TRADEMARK ASSIGNMENT entered into by and among E. I. DuPont de Nemours and Company, a corporation of the United States of America having its head office or principal place of business at 1007 Market Street, Wilmington, Delaware 19898 (the "Assignor") and INVISTA North America S.à r.l. (formerly known as Arteva North America S.à r.l.), a company governed by the laws of Luxembourg, whose full mailing address for the purposes of all related correspondence is 4417 Lancaster Pike, Legal – CRP 722/1032, Wilmington, DE 19805 (the "Assignee").

WHEREAS, Assignor and affiliates of Assignee, among others, are parties to a certain Purchase Agreement, dated as of November 16, 2003, as amended, and related agreements in connection therewith (collectively, the "Purchase Agreement").

WHEREAS, Assignor desires to assign, and Assignee desires to acquire, Assignor's entire right, title, and interest in and to the (i) trademarks applied for and registered in the United States on the dates and under the registration numbers listed in the attached Schedule "A", and (ii) trademark applications applied for in the United States on the dates and under the serial numbers listed in the attached Schedule "B" (collectively, the "Assigned Trademarks").

Therefore, for good and valuable consideration, the receipt and sufficiency of which is acknowledged, the Assignor hereby assigns and transfers to the Assignee, and confirms that it has assigned and transferred to the Assignee, Assignor's entire right, title and interest in and to the Assigned Trademarks and the goodwill of the business connected with the use of, and symbolized by, the Assigned Trademarks.


The Assignor hereby agrees to reasonably cooperate with Assignee in executing, upon request by Assignee and without further consideration, such further documentation as may be required to secure to the Assignee the rights hereby transferred.

Notwithstanding any other provision of this Assignment to the contrary, and except as set forth in and subject to the Purchase Agreement, THIS ASSIGNMENT IS MADE WITHOUT ANY REPRESENTATION OR WARRANTY OF ANY NATURE (A) AS TO THE VALUE OR FREEDOM FROM ENCUMBRANCE OF THE ASSIGNED TRADEMARKS; (B) AS TO ANY WARRANTY (EXPRESS OR IMPLIED, ORAL OR WRITTEN) OF TITLE, NONINFRINGEMENT, MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE (WHETHER OR NOT A PARTY OR ITS AFFILIATES KNOWS OR HAS REASON TO KNOW ANY SUCH PURPOSE), OR ANY OTHER MATTER, INCLUDING THE COMPLETENESS OR SUFFICIENCY OF THE ASSIGNED TRADEMARKS TRANSFERRED HEREUNDER WHETHER ALLEGED TO ARISE BY LAW, BY REASON OF CUSTOM OR USAGE IN THE TRADE, BY COURSE OF DEALING OR OTHERWISE; OR (C) AS TO THE LEGAL SUFFICIENCY TO GRANT ANY RIGHTS THEREIN.


