

WHEREAS, pursuant to a Borrower Intellectual Property Security Agreement recorded in the records of the United States Patent and Trademark Office on October 10, 1995 beginning at Reel 1395, Frame 0852 from Intergraph Corporation in favor of Secured Party, Intergraph granted to Secured Party, among other things, a continuing security interest in certain Trademarks; and

WHEREAS, pursuant to that certain Trademark Assignment recorded in the records of the United States Patent and Trademark Office on July 21, 1998, beginning at Reel 1762, Frame 0859 from Intergraph Corporation to Unigraphics Solutions Inc., Intergraph assigned United States Trademark Application No. 74/721,439 (Registration No. 2,139,423) for the mark SOLID EDGE to Unigraphics Solutions Inc.; and

WHEREAS, pursuant to that certain Change of Name recorded in the records of the United States Patent and Trademark Office on February 17, 2004, beginning at Reel 002796, Frame 0008, Unigraphics Solutions Inc. changed its name to UGS PLM Solutions Inc.
