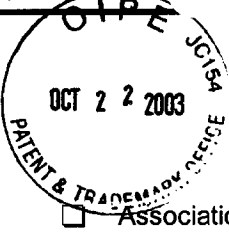

ASSIGNMENT OF TRADEMARKS/SERVICE MARKS

BE IT KNOWN, that for and in consideration of the sum of money to the Seller in hand paid or to be paid by the Buyer, and other good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, the Seller by these presents has sold, assigned, transferred and set over, and does hereby sell, assign, transfer and set over to the Buyer, all of the Seller's rights, titles and interests to the Trademarks in the United States, its territorial possessions and all foreign countries throughout the world together with the goodwill symbolized by the Trademarks together with all claims for damages or injunctive relief by reason of infringements of the Trademarks, with the right to sue for past infringement, and collect the same for its own use and behalf and for the use and behalf of its successors, assigns or other legal representatives.

The Seller hereby authorizes and requests the Commissioner of Patents and Trademarks to issue any and all communications or correspondence pertaining to the Trademarks to the Buyer, as assignee of the entire interest, the same to be held and enjoyed by the Buyer for its own use and enjoyment, and for the use and enjoyment of its successors, assigns or other legal representatives, to the end of the term or terms for which the Trademark registrations may be granted or issued as fully and entirely to the same extent as the same would have been held and enjoyed by the Seller if this assignment had not been made.




