

EXECUTION VERSION**TRADEMARK GRANT OF SECURITY**

WHEREAS, HIG RECOVERY FUND, INC., a Delaware corporation, located at c/o H.I.G. Capital, LLC, 1001 Brickell Bay Drive, 27th Floor, Miami, Florida 33131 ("Grantor"), owns the trademarks and trademarks applications shown in the attached Schedule A (collectively, the "Trademarks"), for which there are recordings or applications in the United States Patent and Trademark Office under the numbers shown in the attached Schedule A; and

WHEREAS, Grantor is obligated to HILCO CAPITAL LP, a Delaware limited partnership ("Hilco") and various other financial institutions (collectively, with Hilco, "Lenders") and Hilco as agent for Lenders (in such capacity, "Agent") pursuant to (i) a certain Loan and Security Agreement, dated as of the date hereof, among Agent, Lenders, Grantor and the other loan parties named therein and (ii) a certain Trademark Collateral Security Agreement, dated as of the date hereof, made by Grantor and other loan parties in favor of Agent (as each may be amended, restated, supplemented or otherwise from time to time, collectively, the "Agreements"); and

WHEREAS, pursuant to the Agreements, Grantor is granting to Agent for its benefit and for the ratable benefit of Lenders a security interest in the Trademarks, all proceeds thereof, all rights corresponding thereto and all reissues, divisions, continuations, renewals, extensions and continuations-in-part thereof, and the recordings and applications therefor.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Grantor does hereby grant unto Agent for its benefit and for the ratable benefit of Lenders and grant to Agent for its benefit and for the ratable benefit of Lenders a security interest in and to the Trademarks, and recordings and applications therefor, which security interest shall secure all the Obligations as defined in the Agreements and in accordance with the terms and provisions thereof and shall be in addition to the grant of security interest under the Agreements.

Grantor expressly acknowledges and affirms that the rights and remedies of Agent and Lenders with respect to the assignment and security interest granted hereby are more fully set forth in the Agreements.
