## RELEASE OF LIEN IN TRADEMARKS

This RELEASE OF LIEN IN TRADEMARKS (this "Agreement") dated as of this 1 day of October, 2003, is made by BNP PARIBAS (formerly Banque Nationale de Paris) located at New York Branch, 787 7<sup>th</sup> Avenue, NY, NY 10019, as Agent for the Lender Parties (as defined in the Credit Agreement dated as of December 22, 1995, and Amended and Restated as of August 1, 2001, among Sportcraft, Ltd., the Lenders party thereto, and BNP Paribas) (the "Assignor"), in favor of Sportcraft Ltd., a Delaware corporation, located at 313 Waterloo Valley Road, Mt. Olive, New Jersey 07828, (the "Assignee"). Unless otherwise defined herein, or the context otherwise requires, terms used in this Agreement, including its preamble, have the meanings provided (or incorporated by reference) in the IP Security Agreement (as defined below).

WHEREAS, pursuant to an Intellectual Property Security Agreement, dated as of December 22, 1995 between Assignor and Assignee, (as amended, restated, supplemented or otherwise modified from time to time, the "IP Security Agreement"), the Assignee assigned and pledged to the Assignor for the ratable benefit of the Secured Parties, and granted to the Assignor for the ratable benefit of the Secured Parties, a security interest in all of the Assignee's right title and interest in specified Collateral, including but not limited to all trademarks, service marks, trade names, trade dress or other indicia of trade origin, trademark and service mark registrations, and applications for trademark or service mark registrations and any renewals thereof, including, without limitation, each registration and application identified in Schedule I attached hereto and made a part hereof, and including without limitation (i) the right to sue or otherwise recover for any and all past, present and future infringements and misappropriations thereof, (ii) all income, royalties, damages and other payments now and hereafter due and/or payable with respect thereto (including, without limitation, payments under all licenses entered into in connection therewith, and damages and payments for past or future infringements thereof), and (iii) all rights corresponding thereto throughout the world and all other rights of any kind whatsoever of the Assignee accruing thereunder or pertaining thereto, together in each case with the goodwill of the business connected with the use of, and symbolized by, each such trademark, service mark, trade name, trade dress or other indicia of trade origin (collectively, the "Trademarks");

WHEREAS, the IP Security Agreement was recorded in the U.S. Patent and Trademark Office on January 5, 1996 at Reel 1417/Frame 0770; and

WHEREAS, as the Secured Obligations have been paid in full, the Assignor has agreed to terminate the pledge assignment and security interest granted to it by Assignee and release its security interest in the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged:

The Assignor hereby releases any and all of its right, title and interest in the Trademarks, and the proceeds thereof, and all rights of Assignor therein hereby revert to Assignee.
