**RELEASE OF SECURITY INTEREST**

WHEREAS, pursuant to the Intellectual Property Security Agreement Supplement dated May 30, 2002 (as amended, the "Prior Security Agreement"), American Safety Razor Company, a Delaware corporation, having its principal place of business at 240 Cedar Knolls Road, Cedar Knolls, New Jersey 07927 (the "Company"), previously granted a security interest in the trademark applications and registrations listed on Schedule A (the "Schedule") to Bank of America, N.A., as administrative agent for the financial institutions (the "Lenders") from time to time party to that certain Credit Agreement dated as of April 23, 1999 (as amended) among the Company, RSA Holdings Corp. of Delaware ("Holdings"), the Lenders, Banc of America Strategic Solutions, Inc. (the "Swing Line Bank") and Bank of America, N.A., in its capacity as administrative agent for the Lenders (the "Prior Secured Party");

WHEREAS, pursuant to that certain Omnibus Amendment Agreement dated as of December 30, 2003 (the "Omnibus Agreement"), by and among Holdings, the Company, the Prior Secured Party and Black Diamond Commercial Finance, L.L.C. ("BDCF"), the Prior Secured Party assigned and transferred to BDCF all of its rights, interest and privileges to the trademark applications and registrations listed on the Schedule;

WHEREAS, an executed copy of the Prior Security Agreement was recorded in the U.S. Patent and Trademark Office (the "PTO") on June 14, 2002, on Reel 2525, Frame 0069;

WHEREAS, an executed copy of the Omnibus Agreement was recorded in the PTO on January 9, 2004, on Reel 2777, Frame 0843 and amended on April 20, 2004;

WHEREAS, to the extent BDCF has any interests in the trademark applications and registrations listed on the Schedule, BDCF hereby releases the security interests in the trademark applications and registrations listed on the Schedule, and the goodwill of the business symbolized thereby.


NOW, THEREFORE, for good and valid consideration, the receipt of which is hereby acknowledged, BDCF hereby agrees as follows:

1. BDCF has not assigned, or otherwise transferred, its aforesaid security interest, or any other interest in any of the trademark applications or registrations listed on the Schedule.
2. BDCF hereby releases any and all security interests granted to BDCF in the trademark applications and registrations listed on the Schedule, and assigns to the Company all right, title and interest it may have in the trademark applications and registrations listed on the Schedule, and the goodwill of the business symbolized thereby.

3. BDCF hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States of America to note and record the existence of the release hereby created.
4. The release of the security interest pursuant to the Prior Security Agreement and the Omnibus Agreement is with respect to the trademark applications and registrations set forth on the attached Schedule.
