RELEASE AND DISCHARGE OF ASSIGNMENT FOR SECURITY

TO: Williamhouse LLC (the "**Company**")

RE: Assignments or Grants of Security Interests (Trademarks) dated as of October 31, 1995 and July 8, 1996 by the Prior Owners (the "**Prior Owners**") of certain assets of the Company (the "**Assignment for Security**") to Bankers Trust Company (the "**Bank**")

WHEREAS the Bank established certain credit facilities for the Prior Owners (the relevant Prior Owners are Karolton Envelope Company, American Pad & Paper Company of Delaware, Inc. and Niagara Envelope Company, Inc.) (collectively, the "**Credit Agreement**");

AND WHEREAS the Prior Owners delivered security agreements dated as of October 31, 1995 and July 8, 1996 to and in favor of the Bank (the "**Security Agreements**") whereby the Prior Owners granted security interests in all right, title and interest of the Prior Owners in and to the trademarks listed on Schedule 1 attached hereto (the "**Trademarks**"), together with the goodwill of the business symbolized by the Trademarks and the applications and registrations thereof, and all process thereof, to and in favor of the Bank in order to secure the prompt payment and performance by the Prior Owners of their indebtedness, liabilities and obligations to the Bank under the Credit Agreement;

AND WHEREAS the Prior Owners further delivered the Security Agreements to and in favor of the Bank, which were recorded in the United States Patent and Trademark Office on the dates indicated on Schedule 1.

NOW THEREFORE, for good and valuable consideration, the Bank does hereby absolutely and unconditionally release, reconvey and forever discharge all security interests, mortgages and other interest in any intellectual property granted by the Prior Owners or any guarantor of the Prior Owners in favor of the Bank pursuant to the Assignment for Security Agreement in respect of the trademarks of the Prior Owners as more particularly described on Schedule 1 attached hereto (collectively, the "**Security**"). The Bank further absolutely and unconditionally releases all of its right, title and interest in and to any and all property, assets and collateral secured, hypothecated or pledged under or by the Security.

The Bank hereby authorizes and directs Paul, Hastings, Janofsky & Walker LLP to complete, file and register any recordation as may be required to fully release and discharge any registration or filing which may be outstanding in favor of the Bank against the Prior Owners in respect of the Security.
