

RELEASE OF LIEN IN TRADEMARKS

This RELEASE OF LIEN IN TRADEMARKS ("Release") is given as of this 10th day of June 2004 by Credit Suisse First Boston, a corporation organized under the laws of Switzerland ("Assignor"), acting through its Cayman Islands Branch, One Madison Avenue, New York, New York 10010, as Collateral Agent for the Lenders under the Security Agreement, dated March 12, 2004 (as amended, restated, supplemented or otherwise modified from time to time the "Security Agreement") in favor of all the Borrowers and Initial guarantors under the Security Agreement (the Borrowers and Initial Guarantors are individually and collectively referred to herein as "Assignee"). Capitalized terms not defined in this Release have the meanings set forth for such terms in the Security Agreement.

WHEREAS, pursuant to the Security Agreement, and pursuant to a series of Assignments for Security, dated as of March 12, 2004, by and between Assignor and certain of the Assignees (the "Security Assignments"), each Assignee pledged and assigned to Assignor and granted to Assignor for the benefit of the Agents and the Lenders, a continuing security interest in all right, title and interest of Assignee in, to, and under the Trademarks including, but not limited to those Trademarks listed on the annexed Schedule 1A, together with, among other things, the goodwill of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof (the "Collateral") to secure the payment, performance and observance of all of the Obligations.

WHEREAS, the Security Assignments were recorded in the United States Patent and Trademark Office on March 22, 2004, at the following Reels and Frames: Reel 2815/Frame 0364 Reel 2815/Frame 0422; Reel 2815/Frame 0091; Reel 2815/Frame 0543; Reel 2815/Frame 0097; Reel 2815/Frame 0106; Reel 2815/Frame 0773; and Reel 2815/Frame 0338

WHEREAS, Assignee has paid, performed, and observed all of its Obligations and Assignor desires to release its security interest in the Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby releases its security interest in the Collateral to Assignee and, without representation, warranty or recourse of any kind, reverts the Assignee with full right, title, and interest to the Collateral.
