Release of Lien on Trademarks

WHEREAS, pursuant to the Primary Collateral Agreement dated as of April 1, 2003, among Neptune Technology Group Inc. ("Debtor"), the grantors party thereto (the "Grantor") and UBS AG, Stamford Branch, as administrative agent (the "Agent") (as amended, the "Collateral Agreement"), which Collateral Agreement was recorded with the United States Patent and Trademark Office on April 7, 2003 on reel 002706, frame 0721, Debtor and the Grantor granted to the Agent a security interest in and lien on, among other things, the Trademark Collateral (as hereinafter defined);

WHEREAS, the Agent desires to release its security interest in and lien on the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Agent does hereby release its security interest in and lien on the Trademark Collateral and reassigns to Debtor and Grantor, as the case may be, all right, title and interest of the Agent in and to the Trademark Collateral and any right, title and interest of the Agent in the Trademark Collateral shall hereby cease and become void. The term "Trademark Collateral," as used herein, shall mean all of Debtor's and Grantor's right, title and interest of every kind and nature as of the date hereof in the Trademarks (as defined in the Collateral Agreement), including without limitation those items listed on Annex I hereto. The Agent hereby agrees, at Debtor's expense, to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of its security interest in and lien on the Trademark Collateral.
