RECITALS

A. Good Guys, Inc., a Delaware corporation (formerly known as The Good Guys, Inc.) ("Grantor"), and Bank of America, N.A., a national banking association, as administrative agent on behalf of the lenders party to that certain Continuing Guaranty, Pledge and Security Agreement entered into as of September 30, 1999, as amended and restated (in such capacity, "Administrative Agent"), entered into that certain Patent, Trademark and Copyright Security Agreement dated as of September 30, 1999, and recorded with the U.S. Patent and Trademark Office on October 6, 1999, at Reel 001972, Frame 0350, with respect to trademarks, pursuant to which Grantor granted to Administrative Agent a security interest in and lien on all of its interest in and to the Intellectual Property Collateral (as defined therein).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent hereby releases its security interest in and lien on the Intellectual Property Collateral including, without limitation, the Trademarks set forth on the attached Exhibit A, and reassigns to Grantor, without representation or warranty, express or implied, and without recourse, all right, title and interest of Administrative Agent in and to Grantor's interest in such Intellectual Property Collateral.


