TRADEMARK ASSIGNMENT

This Trademark Assignment (this "Assignment") is made effective this 30th day of September, 2003, by and between Abbott Laboratories, an Illinois corporation ("Assignor"), and Inverness Medical Switzerland GmbH, a corporation organized under the laws of Switzerland ("Assignee"). Initially capitalized terms used herein and not defined shall have the meaning assigned to them in the Asset Purchase Agreement (as defined below).

WHEREAS, Assignor and Assignee have entered into an Asset Purchase Agreement, dated as of September 30th, 2003 (the "Asset Purchase Agreement"), pursuant to which Assignor has sold certain of its assets and assigned certain of its liabilities related to developing, manufacturing, marketing and selling certain products commonly known as the Fact Plus®, Signify® and Abbott TestPack® product lines (collectively, the "Products"), which includes the trademarks and trade names listed on Schedule A attached hereto (collectively, the "Marks"), to Assignee;

WHEREAS, Assignor has adopted, used and is currently using the Marks in connection with the Products, and has agreed to assign to Assignee all of Assignor's right, title and interest in and to the Marks and the goodwill associated with the use of the Marks in connection with the Products.

NOW, THEREFORE, in consideration of the premises set forth above and in the Asset Purchase Agreement and for other good and valuable consideration, the receipt of which is hereby acknowledged:

Assignor hereby sells, assigns, transfers, sets over and delivers to Assignee, Assignor's entire right, title and interest in and to the Marks (including any common law rights that may exist and are associated therewith), together with the goodwill of the business symbolized by them, the same to be held and enjoyed by said Assignee, its successors, permitted assigns or legal representatives, together with income, royalties, damages or payments due on or after the date hereof, including, without limitation, all claims for damages or payments by reason of infringement or unauthorized use of the Marks, along with the right to sue for past infringements and collect same for Assignee's sole use and enjoyment.






